ADRODDIAD SCAA SBAR REPORT

Sefyllfa / Situation

An application has been made by Margaret Street Surgery in Ammanford to close its branch Surgery in Tycroes. Following receipt of this application, a formal process, agreed with the Community Health Council and the Local Medical Committee, has been undertaken and now concluded. This process has included establishing a Branch Practice Review Group, and undertaking a public engagement exercise. A Branch Practice Review Panel has heard the application and made a recommendation to the Primary Care Contract Review Group.

Cefndir / Background

Margaret Street Surgery is located in the centre of Ammanford and is part of the Amman Gwendraeth (AG) Cluster. It has 9,471 registered patients making it the second largest Practice within the Cluster.

Tycroes is the branch Surgery of the Margaret Street Practice. A Branch Surgery is contractually considered to be a GP Practice site which operates for a minimum of 20 hours per week. **Appendix 1** is an extract from 'Guidance on the Implications of the new GMS Contract on Provision of Buildings to Suit Different Service Models (ref: Para 4.53 – 4.58 of the old Red Book)', which highlights and considers the components needed to qualify as a Branch Surgery. These include;

- 20 hour opening
- Compliance with standards
- Additional and essential services
- Disputes procedures
- Outlying consultation facilities

The Tycroes branch Surgery is located 1.5 miles away from the main site and has been closed for routine GMS provision since the beginning of the pandemic (February 2020). Tycroes was converted into a 'red site' for the Cluster during the pandemic which attracted additional funding from the Health Board (£27,817). The Practice Manager has advised that the site has recently only been accessed by Health Visitors who occasionally use the office space.

Asesiad / Assessment

An application to close the Tycroes Branch Surgery was formally received from Margaret Street Practice on 28th January 2022. The reasons cited for the application are concerns around sustainability due to a decreasing workforce which is preventing working across two sites and the financial burden of a second site.

Before receipt of their formal application, the Practice was provided with the process for closing Branch Surgeries and was asked to provide an up-to-date Sustainability Matrix, which was received on 31st January 2022.

In line with the documented process, Hywel Dda Community Health Council (CHC) was made aware of the application and subsequently, a meeting took place on 1st February 2022 with the Deputy Chief Officer of the CHC, the Margaret Street Practice Manager and the Health Board to discuss the engagement element of the process.

The CHC agreed to provide timelines and structure around the engagement process and highlighted the need to work closely with Hywel Dda University Health Board's Engagement team to discuss the breadth and depth of the engagement required, given the current pressures and restrictions.

A meeting took place on 11th February 2022 with the Engagement team to discuss requirements and expectations, and clarity around the engagement process was obtained. The Branch Practice Review Group was established, which includes representation from Hywel Dda Community Health Council and Dyfed Powys Local Medical Committee (LMC) and an engagement plan was agreed (attached for information at *Appendix 2*).

The activity period for this work took place between Monday 9th May 2022 to Friday 24th June 2022 with the purpose of the exercise being to:

- Provide opportunities for our patients and stakeholders to give their views.
- Raise awareness of the engagement and provide opportunities for feedback.
- Target those who use the service through engagement methods that are most appropriate for these groups.
- Identify appropriate engagement and communication tools and methods to effectively engage.

The engagement period provided stakeholders with an opportunity to participate through providing their views by answering the following question "How do you feel about Margaret Street Surgery's application to close their Branch site in Tycroes". Responses could be submitted by telephone, letter, scanning a QR Code, email or by completing paper slips that were available from Margaret Street Surgery, Tycroes Branch Surgery and Tycroes Pharmacy. A summary of this engagement is included at *Appendix 3*. The main themes of concerns raised can be categorised as transport, parking, appointment capacity at Margaret Street, convenience, ease of access for local community, care being moved further from home and loss of service.

As part of the opportunity to engage in the public consultation, a group of residents have presented the Health Board with a petition of 1822 signatures opposing the closure of Tycroes Branch Surgery.

The Health Board was made aware of a public meeting on 11th June 2022, facilitated by local politicians. Comments received from this meeting have been included in the feedback summary.

The CHC Executive committee met on 30th June 2022 and, in summary, believes that Tycroes branch surgery should remain open and accessible to the public (*Appendix 4*)

An Equality Impact Assessment is included at *Appendix 5*.

In line with the agreed Health Board process, a Branch Surgery Panel was convened on 11th August 2022. The panel was chaired by the Vice Chair of the Health Board and members included the Local Medical Committee and the Community Health Council. The Practice was represented by the Practice Manager, who outlined the rationale for the proposed closure. In considering the level of feedback received, both through the agreed process, the petition and the local political meeting there were two options for consideration which are detailed in the table below.

In considering all of the facts presented to them, the Branch Surgery Panel concluded that the recommendation to the Board would be to decline the application from the partners of Margaret Street Surgery to close the Branch Surgery at Tycroes and to offer support from the Primary Care team to assist the Practice in considering best use of the premises.

Guidance on the Implications of the new GMS Contract on Provision of Buildings to Suit Different Service Models (ref : Para 4.53 – 4.58)

Paragraph 4.54 of "Investing in General Practice" states that "For a branch surgery to qualify as a second main/split-site it should meet the following criteria:

- (i) be open for at least 20 hours a week for provision of medical services automatically entitling it to proper IT support;
- (ii) meet the minimum standards set out in paragraph 4.52;
- (iii) deliver essential and additional services."

Components:

- 1 20 hour opening
- 2 Compliance with standards
- 3 Additional and essential services
- 4 Disputes procedures
- 5 Outlying consultation facilities

Each element will be considered in turn.

1 Hours Opening for Branch Surgeries

Issues of hours of opening will be critical to determining whether LHBs should be funded for the premises costs of provision of services from a branch surgery. The 20 hours should not be the time the doors are open, and receptionists are available, but reflect the times that clinical services are being provided.

For the purposes of this issue, clinical services should include those provided by GPs, practice nurses, community nursing services and dispensing services. Services being provided by non-GMS funded staff can be included, but administrative services such as the collection of repeat prescriptions cannot.

Current branch surgeries have not developed services within the 20 hour framework, and LHBs will have to use their judgement on whether to support surgeries open for less than 20 hours. In some cases, it may be desirable to agree shorter opening hours, for example in rural areas where there is no realistic alternative to the branch surgery.

2 Compliance with Quality Standards (para 4.52)

Subject to appropriate funding agreed between LHBs and practices, premises will not be accepted unless the accommodation is deemed by the LHB, following a visit, as satisfying the minimum standards.

Schedule 1 of the National Health Service (General Medical Services – Premises Costs) (Wales) Directions 2004 sets out the minimum standard for practice premises.

LHBs should use the results of the premises survey commissioned by Welsh Health Estates to inform the initial judgement. This should be followed up by a visit using the Quality Standards – Practice Premises Inspection Report. LHBs will also need to link decisions about the future of branch surgeries to their integrated service and estate strategies.

There are a number of courses of action that can apply following an inspection of a branch surgery:

- (i) Where the premises does not meet the quality standards and is not supported by the estate strategy then there are 2 options:
 - The LHB and GP can agree to closure and follow the closure procedure;
 - If the GP does not agree with the LHB's decision to disinvest in the premises there is an appeal procedure to the Welsh Assembly Government
- (ii) Where the premises does not meet the quality standards but is supported by the estate strategy then there are 2 options:
 - a) If there is long term commitment to the current building then a refurbishment programme would need to be agreed;
 - b) If there is a need for replacement of the premises then an interim investment plan would need to be agreed to ensure that the premises meet an acceptable standard in the interim period before closure and transfer to new premises.
- (iii) Where premises meet the quality standards and are supported by the estate strategy but the GP wants to close then the GP will need to issue an application to close. There will be a given period in which the LHB can issue a counter notice, to allow for any necessary consultation. It is recommended that the LHB involves its Local Medical Committee in trying to resolve the issue. The surgery will be required to stay open until the issue is resolved. Normal appeal procedures will apply.

LHBs may wish to consider whether there are any procedures contained within the premises flexibilities, issued in WHC (2004) 06 in January 2004, which could facilitate these actions. Further information can be found in the guidance on quality standards of GP premises.

3 Additional and Essential services

Branch surgeries should always aim to deliver both essential and additional services. However, some additional services would only be provided when it was deemed appropriate by the LHB following discussion with the practice, and with regard to the quality standards. For example, minor surgery may require additional facilities which are not economic within a branch setting.

4 Disputes procedures

These are explained in Part C of 'Delivering Investment in General practice – Implementing the new General Medical Services Contract in Wales'. Part 7 of the National Health Service (General Medical Services Contracts) (Wales) Regulations 2004 sets out procedures that need to be followed.

5 Outlying consultation facilities

Paragraph 4.57 states that "branch surgery standards need not be fully met where a practice provides outlying consultation facilities using premises usually used for other purposes."

There are a number of issues with such outlying facilities:

- IT and patient notes may not be available for a patient consultation;
- not all the minimum quality standards need apply, but some will have to. Those covering privacy, infection control, and clinical waste disposal in particular have to be met;
- privacy can best be tested by whether the GP has a dedicated room for their surgery sessions;
- infection control will be subject to developing guidance being agreed by the Royal College of General Practice and Assembly;
- clinical waste disposal will again be subject to important procedures covering storage, handling and transport. GPs should take the necessary steps to ensure that sessions are provided in rooms where the GPs have exclusive possession. Where this is not possible then LHBs should consider the introduction of mobile service units, where appropriate.

In many respects, however, the surgery sessions will be little different to a series of home visits where all these issues will apply but be overcome. LHBs will need to weigh up the advantages in terms of access of supporting such clinics with the disadvantages in terms of quality of service delivery.

6 Summary

LHBs' decisions regarding branch and split site surgeries should be made on the basis of service delivery and not solely on financial grounds. Each LHB will need to provide evidence of their assessment of these premises, and have developed an action plan for their Management Board's approval.

- Disputes procedures
- Outlying consultation facilities

Detail of the opening and provision of services of Tycroes prior to the COVID-19 pandemic is included in the application letter from the Practice, but generally, prior to February 2020, the branch was open Mon – Fri 8.30am – 12pm

The Tycroes branch Surgery is located 1.5 miles away from the main site and has been closed for routine GMS provision since the beginning of the pandemic (February 2020). Tycroes was converted into a 'red site' for the Cluster during the pandemic which attracted additional funding from the Health Board (£27,817).

The Practice Manager has advised that the site has recently only been accessed by Health Visitors who occasionally use the office space.

Proposed approach for engagement activity

Any engagement will need a broad brush approach encompassing the wider population together with targeted activity around those potentially most affected, as identified by the stakeholder mapping.

The purpose of this engagement exercise is to:

- Provide opportunities for our patients and stakeholders to give their views.
- To raise awareness of the engagement and provide opportunities for feedback.
- Target those who use the service through engagement methods that are most appropriate for these groups.
- Identify appropriate engagement and communication tools and methods to effectively engage.

The engagement activity period for this work will take place Monday 9 May 2022 to Friday 24 June 2022.

This period will provide those who are interested to have an opportunity to participate through providing their views by answering the following question "How do you feel about Margaret Street Surgery's application to close their Branch site in Tycroes" by phone, letter, email or placing views in feedback/response boxes at the Margaret Street Surgery and Tycroes Branch Surgery.

Tycroes is an expanding village in terms of new houses but also has an ageing population. Getting an appointment at Margaret Street Surgery, prior to, during and since the easing of Covid restrictions, is no easy task. It takes forever to get through on the phone, appointments are on the day appointment, so if you can't get through early enough then you may not be seen that day, or you are advised that a nurse will ring you but no timescale can be given for that. Therefore, you can be waiting about for a phone call which may not happen for a few hours. Not everyone has mobile phones! You aren't allowed to book a non urgent appointment in advance and in my case, after receiving a letter to make an appointment with a GP regarding my recent blood tests, I had to wait Five weeks for a telephone consultation, despite allegedly, six GP's working!!! I would seriously question Margaret Street GP's, how they intend to resolve the current unsatisfactory situation regarding access to timely and appropriate appointments. Blood tests are no longer performed at Margaret Street Practice due allegedly, to the Health Board withdrawing funding for this procedure. Purpose

To agree the CHC's stance on the application by Margaret St. Surgery in Ammanford to close Tycroes branch surgery. The wording in this paper would be carried over and used to form our submission to the Health Board's Primary Care Contract Review Committee (PCCRC). The PCCRC will recommend that the application is either refused or accepted by the Health Board's Executive Team. We would also use the stance in this paper to develop a press release and deal with any media enquiries.

Background

The CHC first learned of the application to close Tycroes in January 2022. Work began immediately with the Health Board to understand what was being proposed and how public engagement should be designed and structured.

Role of the CHC in Service Change

Community Health Councils have a particular role regarding NHS planning or service change which is set out in Welsh Government Regulations (2015). This specific role has been subject to more detailed Welsh Government guidance which addresses the roles of NHS organisations and CHCs in relation to the processes of service change and public consultation.

Our role in planning the public engagement process

Through meetings with the Health Board and Margaret St. Surgery representatives we worked together to agree a public engagement plan. The approach was agreed by an extraordinary meeting of the CHC Executive Committee on March 10.

- Aims: as we helped to plan the engagement in February and March we felt that traditional methods of face-to-face engagement were risky with the continued circulation of Covid-19 and community infection rates. We believed that some people would wish to stay at home rather than attend public gatherings and that other methods were needed, utilising a mixture of written and virtual feedback. Press releases were produced which led to news media coverage and the Health Board offered a dedicated phone line for people to pass on their views. We acknowledged that public engagement had to be delayed due to pre-election period rules surrounding Council elections on May 5.
- Duration: we initially felt a 6 week engagement period would be proportionate but subsequently asked that this was extended to 7 weeks to take account of the public holidays surrounding the Queen's Jubilee. The Health Board agreed to accommodate this.
- Mid-Point Review: we asked for a review meeting with the Health Board to assess whether changes needed to be made to the engagement approach. This meeting was slightly delayed but took place on the 9th of June. We felt that no substantial changes were required in terms of methods but welcomed the Health Board's aim to encourage more involvement by the public leading up to the end of the period.

What we thought about the engagement process

We felt that the Health Board listened to what we had to say when the engagement process was being planned and during course of the 7 week process. The Health Board ran regular "Branch Practice Review Group" meetings that the CHC attended prior to and during the engagement period. Representatives of Margaret St. practice were also regularly present and were supportive and helpful in their approach. Anonymised public views were shared and the engagement process or emerging issues were discussed. We were also pleased to see that the Health Board and the practice responded to questions from the public during this time.

There were some minor issues reported in getting some additional printed materials for the public to Tycroes pharmacy but this was resolved relatively quickly.

Public involvement in the engagement started slowly despite local news media coverage but gained momentum through the 7 weeks. It led to a range of local social media activity and increased numbers of responses received by the Health Board. Ultimately local politicians became involved, a public meeting was held (organised by Lee Waters MS) on 11 June which the CHC attended and a local petition was subsequently presented that received 1822 signatures. Subsequently there was further news media coverage. Over 220 responses were received by the Health Board and vary from a single sentence to longer and quite detailed statements.

What people said during the engagement

We are grateful to the Health Board for sharing the anonymised public comments that they have received during the engagement period.

Themes:

- There was almost total opposition to the proposed closure amongst public responses
- By far the most common concern raised by people related to increased travel distances, transport and associated issues such as parking in Ammanford to attend Margaret St. surgery. It was felt that travel was difficult for some and that catching a bus can be far from ideal in terms of timetabling and when people are

unwell. Some said that the location of the surgery at Tycroes allowed them to maintain their independence, whilst needing to attend Margaret St. meant that they had to rely on friends or relatives.

- Some people felt that Margaret St. in Ammanford could be very busy and congested at certain times. Crossing the road was difficult for wheelchair users, the elderly and people pushing pushchairs, particularly in the absence of a formal zebra or pelican crossing nearby.
- Some were concerned that the closure of Tycroes would lead to fewer appointments although the Practice has stated that GP time would be freed by the change through less travel.
- Some made comments surrounding the population in Tycroes, saying that there was a high proportion of older people and a growing population due to housing developments.
- One of the most interesting aspects of the engagement was that many people were less worried about the proposed permanent removal of doctors from the site, and more concerned that it would be lost as a more general healthcare resource to the community. A number of people felt that clinics and the attendance of other health professionals could be beneficial. For example (although a separate issue), many were concerned about how difficult it was to access blood tests in the area.

Our Conclusions

In presenting the CHC's conclusions, it is important to highlight the respective roles of the Health Board and CHC within this process. The Health Board holds a contract with GP practices. If it receives an application to close a branch surgery it must decide whether to accept or reject it. It will do this through understanding the practice, the problems and opportunities it faces as an individual contractor. It must also give due consideration to the needs of the community it serves.

As set out at the start of this document, the CHC has a statutory role in NHS service change, ensuring that the Health Board engages effectively with the public. The CHC will also develop its own balanced view based on what the public have said.

CHCs are not in a position to take an expert stance on the complex and challenging logistics within an individual GP practice. Our focus is $_{\rm Page\ |\ 4}$

on ensuring that our conclusions are based on the real-world impacts of service change proposals on people, ensuring these impacts are understood and incorporated into decision-making. CHC members have taken the opportunity to absorb the points made by the practice in their application including the challenges it faces and data provided (e.g. historical numbers of appointments etc.)

Having considered information available and public feedback during the engagement period CHC makes the following points:

Tycroes branch surgery closure application and the CHC's summary view

The CHC believes that Tycroes branch surgery should remain open and accessible to the public. We agree that there is a difficult balance to achieve between practices acting proactively and decisively to ensure their long-term sustainability for patients versus continuing the challenging logistical struggles of running two or more sites day-to-day. Acknowledging this, we feel more needs to be done to explore how Tycroes branch surgery can deliver care to local people in the longer term.

"Strategic fit" and "Care Closer to Home"

In its strategy "A Healthier Mid and West Wales" the Health Board aspires to provide health services that keep people well, prevent ill-health or the worsening of ill health. It also says that it is working in communities to provide more joined-up support and care "as close to home as possible". As a general point the CHC is concerned that closing branch surgeries will take care further away from home and this was reflected in what many people had to say.

Therefore, the CHC feels that any primary care closure risks isolating a community from the "front door" of NHS services and must only be considered as a last resort in the face of strong sustainability issues. There may be opportunities to run additional clinics or services from Tycroes. The development of Cross Hands Health and Wellbeing Centre and the services that could be provided from it may require a new conversation in relation to Tycroes, but this project is currently at the business case stage and wouldn't open until 2024/25.

Precedent setting and branch surgeries

Carmarthenshire GP practices operate 10 branch surgeries across the county. The CHC is concerned that whilst branch surgeries can provide a significant additional challenge to practices (particularly if they encounter staffing problems or see substantial increases in demand) they are also key to primary care infrastructure in the county. We know that the Health Board is required to look at any closure application on its individual merits but would still be concerned that one closure may set a precedent for others.

Convenience and Travel

The word "convenience" often focuses on how easy something is to do rather than the barriers that have been overcome to achieve it.

Many of the public who took part in the engagement were clear that the removal of the convenience of Tycroes would therefore create barriers, whether these were manageable or not. We know that some people in communities experience genuine struggles even if they have to travel an extra couple of miles, find transport, find parking etc. Bus services can be helpful and we note how close Ammanford bus station is to Margaret St. however, some Tycroes residents would need to walk 3-400 metres to their nearest bus stop. This can be difficult for some particularly if they are unwell. The area can be busy and congested making Ammanford's Margaret St. difficult to cross.

Regrettably, sometimes changes that make travel more difficult are unavoidable in healthcare, but we would like to see more discussion between the Practice and Health Board before a decision is taken that branch closure is unavoidable.

The effect of the Tycroes pandemic closure

The CHC noted that Tycroes had been closed during the pandemic. Although the Practice's application highlighted that the public had adapted well to accessing care via Margaret St. with no complaints received, the CHC would like to raise two observations.

Firstly, we observed a great deal of stoicism and pragmatism by the public through the Covid pandemic and therefore we don't necessarily view the lack of complaints as tacit acceptance of closure. This view seems to be supported by the engagement responses and the

apparent depth of feeling behind them, i.e. the closure was tolerated on the basis that it was temporary.

Secondly, the period of closure at Tycroes has led to an unusual situation in terms of NHS service change, in that it has acted as a kind of *ad hoc* "pilot" study. The public have tried it and they seemed to find it unhelpful. Often, public reaction to proposed change is based on fear of something new and can hinge on a lack of trust, but people have lived with this situation and consequently they have reflected based on their experiences.

Population Need

The CHC does not have detailed demographic information which describes the health needs of people in the Tycroes area. There was a theme within the engagement responses that the proposed closure could disproportionately impact older people or those with greater health needs. Whilst the CHC cannot verify the claim that there are greater health needs in the area affected by the proposed closure, we would expect the Health Board to take that question into consideration as it considers the proposal.

The Practice Manager has advised that the site has recently only been accessed by Health Visitors who occasionally use the office space.
		An application to close the Tycroes branch was formally received from Margaret Street Practice on 28 January 2022. The reasons cited for the application are concerns around sustainability due to a decreasing workforce which is preventing working across two sites and the financial burden of a second site.
		In line with the documented process, Hywel Dda Community Health Council (CHC) was made aware of the application and subsequently, the Health Board, CHC and Local Medical Committee (LMC) have worked together to develop a public engagement plan to generate patient and stakeholder feedback.
		The aim is to embed the EqIA into the Health Board process to ensure a 'patient centred approach that values the criteria of fairness and equality and compliance with public sector duties for race, gender and disability equality'.


