Sefyllfa / Situation

The Director of Public Health (DPH) is required to produce an Annual Report every year. As HDdUHB's DPH, Mrs Ros Jervis, retired due to ill health at the end of March 2022, and subsequently passed away, the focus of this Annual Report will be to pay tribute to the leadership shown during her time in the role, and to celebrate the legacy that she has left.

Since this is a tribute from those who knew and worked with Ros, we decided to use a video interview format for this report to capture Ros' impact most effectively. Once approved, the video will form part of a suite of resources on the Health Board website, linking to previous Annual Reports, the Health Wellbeing Framework, and future Public Health interventions and intelligence.

Cefndir / Background

Previous DPH Annual Reports have focussed on Health Inequalities (2020/21) and the Health Wellbeing Framework (2018/19). These reports have highlighted developments in the preceding twelve months, set out the course of action for the future, and identified longer term ambitions to improve population health and wellbeing.

During 2021/22, ill health prevented Ros from participating in work for much of the year. Following her death, the Public Health Team agreed that the focus of this year's report should

be on Ros as an individual and on her achievements during her time in post as the DPH between 2017 and 2022.

Asesiad / Assessment

The report contains reflection from senior colleagues within the Health Board, Public Health Wales, and representatives from partner organisations across the three local authority areas within Hywel Dda. These individuals were asked to reflect on the leadership that Ros showed during her time as DPH, and to give their views on the legacy that she has left behind.

The Health Board is committed to the implementation and further development of the Health Wellbeing Framework developed by Ros. This report captures the legacy of that work in changing the conversations about prevention, identifies the support for continuation of Ros' vision, and harnesses the energy and enthusiasm amongst the Health Board and its partners to work together to honour Ros' legacy.
